University of Kalyani, the Hon's. (Hons.) Course in Accountancy and
the Degree (Hons.) Course in Political Science were introduced in the
Kanchrapara College, P.O. Kanchrapara, Dist. 24-Parganas with effect
from 1976-77 and 1980-81 session respectively without obtaining
prior approval of the State Government in this regard. The Uni-
