Course in Political Science were introduced in the Kanchrapara College, P.O. Kanchrapara, Dist. 24 Parganas with effect from 1976-77 and 1980-81 session respectively without obtaining prior approval of the State Government. The University of Kalyani has, however, been requested to obtain the views of the State Government before granting recognition to any of its affiliated colleges for open new courses/subjects.
