Response:

While it is true that the date of the final agreement or the issuance of work order is beyond the assessment period, the HEI would like to state that the process of vendor selection and calling of tenders for e-waste disposal had been initiated long before, in September, 2022 with the approval of the Governing Body on 09.09.2022 (scanned copy of resolution attached).

A scanned copy of the e-tender and a comparative study done on 16th December, 2022 is also being attached.

The entire process got withheld and delayed due to the Covid 19 restrictions frequently shutting down the colleges. We request that the noble initiative, though delayed, may please be considered, more so in the face of the pandemic and the time consumed by the revival of a collapsed economy.
