Tender Notice for Kanchrapara College Canteen

Sealed quotations are invited from interested parties for running Canteen at Kanchrapara College, Kanchrapar, North 24 Pgs.

1. Last Date of Submission/drop into Tender Box: -18.03.2023 upto 2.00p.m.
2. Opening date of the tender notice: In the meeting of the Canteen Committee.

The scope of work includes the following:-

- I. To run the Canteen at the College canteen building including supply of raw materials and man power for cooking and serving etc.
- II. To fix the menu in consultation with the Canteen Committee of the College from time to time.
- III. To supply Tea/Coffee/Cold Drinks, food and snacks.


Terms & Condition for award for canteen contract for Kanchrapara College

1. A well canteen building, Furniture, Water connection and Electricity will be made available free of cost.
2. The bid is invited to run the Canteen for 2 years and the same may be renewed /revoked for next eleven months at the discretion of the College.
3. The vendor will not be allowed to use electric coil /heater or hot plates.
4. No responsibility will be taken by the College for Credit Sales or losses.
5. On acceptance of the tender the contractor shall deposit a security of Rs. 5,000/- in favour of Kanchrapara College refundable at the termination of contract.
6. The contractor shall be liable to execute a written agreement on a non - judicial stamp paper of Rs. 10/- before taking over charge of the canteen premises.
7. The contractor should take all safety measure to while running canteen and keep the neat & clean.

8. The contract will be operative for a period of two years from the date of award but the College can extend it for another period of one year subject to satisfactory working on the terms & conditions as determined by the College.
9. The contractor will be bound to maintain sanitary conditions in and around the canteen. No College staff member will be engaged for the purpose and it shall be entire responsibility of the contractor to remove canteen waste at their own responsibility.
10. The contractor will be bound to pay necessary fee, taxes as applicable, according to the rates prescribed by the concerned authority or any other authority for running the canteen, directly to concerned authorities.
11. The contractor should have Aadhar Card, PAN card and Food License.
12. Cost of food & beverages must be competitive and reasonable as the room rent is waived by the College. Any change of prices of some basic item / different items will be fixed in consultation with the Canteen Committee.
13. The employees of vendor should be dressed properly in a uniform and to maintain cleanliness.
14. The utensils, fuel charges/Gas charges should be borne by the Vendor.
15. Price list must be displayed at the canteen.
16. Food & beverages (including raw materials) must be of best quality.
17. Functioning of canteen should start within 7 days from issue of the formal work order. The canteen will be remained open in all working days during office hours and sometimes in holidays also as and when required by the College.
18. The rate quoted by the vendors for various food and beverages should be composite and inclusive of all taxes and other incidental charges, if any. The prices quoted shall be written in figures and words as well.
19. The College reserves the right to accept or reject any bid on any of the above grounds or absence of Infrastructure or without any reason whatsoever.
20. The College reserves the right to terminate the contract after giving the month's notice to the vendor.
21. Only proposals received on or before the stipulated date and time for responding to the tender will be considered for further evaluation.
